1	<p><b>ELIGIBILITY:</b> The 2006 NFL Fleer Ultra Signed Rookie Photo Shoot Redemption Sweepstakes (the “Game”) is open only to legal residents of the fifty (50) United States and Canada and you must be thirteen (13) years of age or older as of May 15, 2006.
